## **SLFFA MEMBERSHIP APPLICATION FORM – ASSOCIATE MEMBER**

Further to your request for a new application, please find enclosed the membership application form of the Sri Lanka Logistics & Freight Forwarders Association. The criteria for membership of the Association are that a company should:

- 1) Any Limited Liability company actively engaged in the business of International Freight Forwarding and/or Logistics Services in Sri Lanka for not less than 1 year, but which does not meet the pre-requisites to be an General Member may apply to be an Associate Member having a minimum Stated Capital of Rs. 5,000,000.00;
- 2) Members should conduct their business as per the Standard Trading Conditions (STC) of SLFFA.
- 3) Minimum of one Board member of the applicant to possess atleast 3 years experience in the field of international freight forwarding (please include supporting documents such as appointment letters/service letters etc. and include profiles of each Board Director).
- 4) Have obtained forwarders all liability insurance cover from a recognized insurance company.
  - Legal Liability USD 100,000/-
  - Errors & Omissions USD 50,000/-
- 5) An application for membership should include,
  - a) Copy of the Memorandum and Articles of Association of the Organization
  - b) Copy of Business Registration
  - c) Recent copy of Form 48 or Form 20 duly stamped by ROC
  - d) Certification of Stated Capital from applicant's auditors confirming the value in Rupees
  - e) Letter from Principals, Agents if any, confirming the relationship.
  - f) Original copies of all B/L and negotiable documents currently issued
  - g) Liability Insurance Coverage.
  - h) References from the Chairman, MD or CEO of two SLFFA Ordinary member Companies who have completed 5 years of membership of which one should be from the Executive Committee. Furthermore, a director/shareholder who holds a position in the applicant's company/a similar industry cannot provide a recommendation letter.
  - i) Copy of Director Merchant Shipping Registration – Class "B" license

All prospective applicants shall be subject to a random inspection of its facilities and shareholding registers as deemed necessary by the Executive Committee.

Please note that, once aforementioned documents are submitted your application will be tabled at the SLFFA Executive Committee meeting and as final stage of the process, you will be requested to submit an Affidavit & a letter of adherence. (Format of the Affidavit & the Letter of Adherence will be shared when required).
